- Promote environmental responsibility in areas including, but not limited to, reduction of greenhouse gases, waste management and disposal, conservation of energy and other natural resources, and creating systems to store and manage documents electronically to reduce paper use.

Raise awareness of the importance of environmental issues among employees, customers and suppliers by participating in and promoting events such as Earth Day, Environmental Awareness Month, Zero Emissions Day, and Energy Efficiency Day.

- Utilize prudent, ethical and transparent business practices
- Follow all applicable ethics laws internationally, federally, and in state, county or municipal jurisdictions
- ➤ Demonstrate preventive measures to prevent corruption, fraud, bribery, money laundering, conflicts of interest, and data security breaches or issues

Labor and Human Rights

- Follow all applicable labor and human rights laws internationally, federally, and in state, county or municipal jurisdictions, and in accordance with the principles of the International Labor Organization, the UN Global Compact and the UN Universal Declaration of Human Rights
- Prohibit slavery and the use of forced, bonded, or child labor across the supply chain
- Prohibit unlawful discrimination, bullying and harassment to provide a safe and inclusive work environment

- Partner with local governments and communities to improve the education, culture, economic and social well-being of communities in which they operate
